Councillor Bartlett declared a non-pecuniary interest (Dorset Council Ward Councillor) and did not vote in relation to minute reference PEC/2024/079.

## PEC/2024/077 Public participation

It was agreed to move item 11 (i) (Birchdale Road) to the next item of business to accommodate the five residents of Birchdale Road. A resident confirmed they were independently seeking town/parish green status for a piece of amenity land and Councillor Wheeler requested the residents re-contact the Town Council if they needed support with this project. The five members of the public were thanked for attending and left the meeting.

### PEC/2024/083 Wimborne Neighbourhood Plan

Councillor Wheeler provided the Committee with an update on the Council's proposal to create a Neighbourhood Plan, outlining the numerous benefits it would bring to the town and its residents. A discussion followed on the most effective way to facilitate the plan's development. The Town Clerk presented three quotes from specialist companies to assist in the creation of the plan. Councillor Hector proposed to recommend quote one to Full Council, seconded by Councillor Wheeler, eight in favour, one abstention. **Resolved** 

#### PEC/2024/084 Safer Streets in Wimborne

The Deputy Town Clerk updated the Committee on a recent online presentation by the group "20's Plenty for Dorset." Several councillors had also attended the session and Councillor Richmond provided feedback on the group's policy advocating for bringing Dorset in line with the rest of the UK regarding 20mph speed limits. This was noted by the Committee.

## PEC/2024/085 Update in relation to actions from previous meetings

The Deputy Town Clerk informed the Committee that Dorset Council were to carry out a site visit at Cranborne Chase and other areas and further details would be shared once confirmed (see previous minute PEC/2024/051).

## PEC/2024/086 Correspondence

- (i) The Committee reviewed correspondence from a resident requesting the placement of yellow lines in Lewens Close. The Committee requested the Deputy Town Clerk obtain additional information from the resident including any access issues for emergency and Dorset Council utility vehicles.
- (ii) Councillor Wheeler raised concerns about dangerous parking on St John's Hill, Wimborne, particularly regarding the lack of enforcement against vehicles parking on yellow lines. The Committee requested the Deputy Town Clerk contact Dorset Council for an update on the enforcement situation and report back.
- (iii) The Committee noted the correspondence from Colehill Parish Council regarding opposing the 20mph scheme on Burts Hill. The Committee requested the Deputy Town Clerk obtain an update from Dorset Council on this scheme and report back.
- (iv) The correspondence regarding Dorset Council Tree Strategy and opportunities to increase tree cover in the town from Nicola Harper were noted. It was agreed to carry out enquiries with the local county association and report back.
